Carlos -

We are working toward a proposal which I hope to complete today that would significantly reduce the redactions and withholdings that are in dispute.

In the interim, I have some questions about the documents produced to date.

1. The Vaughn Index states that it "lists each responsive **document** withheld in full ("WIF") within FOIPA Request No. 1326525." The following 166 **pages** with your following "Broward Bulldog" Bates numbers have been withheld in full but are not on the Vaughn index. Am I correct that this is because these pages are parts of documents that have been partially released? If so, can you identify by Bates numbers, the partially released documents of which they are a part?

- 2. The Meese Commission Report states at page 106: "The Review Commission requested and received a briefing regarding the press allegations. The Review Commission also obtained a copy of the case file, copies of documents released through the Freedom of Information Act regarding the matter, and reports of interviews. FOIA Request No. 1326525 (April 8, 2015) specifically requested "the 'Sarasota family' case file, including reports of interviews, reviewed by the Commission." Have those documents been located and included in the productions to date? If so, what are the corresponding Bates numbers? I have not seen any documents which appear to be the case file or reports of interviews reviewed by the Commission.
- 3. FOIA Request No. 1326525 (April 8, 2015) also sought "staff and draft copies of the final report" and asked for identification of the number of pages that remained classified and the FOIA exemption under which classified pages were being withheld. Are the pages of the Meese Commission Report that remain classified within the documents produced? If so, what are the corresponding Bates numbers?
- 4. Broward Bulldog 1509 appears to be a photograph of New York City. Has this document been previously released and can you tell me anything about the origin of the document?
