11/24/14 ~~on his date~~ Michael Bigwood called my cellular telephone over 50 times and sent over 100 text msgs causing me to have to leave my job. Michael threatened to kill himself and stated that he did not want anyone in his family left living. He then text me that he was waiting for me at my residence and due to fear of harming me or the children I had to find an alternate place to stay for the night. Michael is a police officer in the City of Lauderdale and is always armed. He owns multiple firearms and has threatened to use them. ~~Michael~~ I left Michael in 2010 due to ~~being~~ violence where he pulled a firearm on me and threatened to kill me and our children. We were divorced in 2011. Michael began therapy through a psychiatrist and was on antidepressant medication. In 2012 I tried to mend our relationship for the children. While on medication, Michael was a good father and significant other, however in 2013 he stopped taking his medication and began drinking heavily. While intoxicated, Michael has become violent and in July 2014 he grabbed me and threw me out of his pick up truck, throwing me to the ground and causing bruises on my legs. During this same time, while my 7 year old daughter was sitting in my lap, Michael stood over us, not allowing us to get up, and screamed violently that he hates me ~~and~~ <sup>over and over</sup>. He ~~also~~ <sup>screamed</sup> at us that I was

His erratic aggressive behavior placed myself and my daughter in fear, because we could not leave, and it was apparent that he had lost control of his temper. On 11/30/2014, I recieved multiple phone calls and text messages again, over 100 together. He called me names such as whore, cunt, and shit. I have asked him to stop calling and texting, he refuses.

At this time I am worried for the safety of my children due to his behavior, I am filing for an injunction for them, however because I know how angry this will make him I am in fear that he will retaliate and come after me. He stated that the children are the only thing keeping him alive and if I recieve this injunction for them he will loose his temper, get drunk and he will not be able to control his behavior.
