All I could hear was GREG saying, "I want it now, I want it now", and HECTOTER was telling him, "you got to see who is responsible". Then GREG wanted to fight with HECTOR but HECTOR wouldn't fight him and then GREG ran into his house there, the one with the brown door that I showed you, (2828 N. Hutchinson St.), and in a couple of seconds he was coming out the front door again. His Pop tried to keep him from going back outside but he got past his Pop and then I seen that he had a gun and he just started to shoot HECTOR. I heard 6 shots and I saw HECTOR start to fall down on the street and that's when I started to run to HECTOR's housed and tell his Mom. While I was running I could hear GREG's POP yelling, "you didn't have to shoot him, you're best friends". By the time I got HECTOR's Mom and went back to where he was, GREG was gone. I don't know where he went or where his father went.
- Q. When you went back to where HECTOR was on the ground after he had been shot, did he ever say anything?
- A. He couldn't, everytime he opened his mouth, blood just came out.
- Q. Did you see any kind of weapon, a gun or a knife, in HECOTOR"S hands today?
- A. No, I never seen nothing in his hands.
- Q. How long have you known this GREG who you saw shoot HECTOR?
- A. For about 6 months.





Hutchinson St. when he saw the deceased, Hector Rodriquez and Gregory in the street arguing. During the argument, Greg left and entered 2828 N. Hutchinson St. A very short time later Greg exited the residence holding a gun and walked up to Hector and pointed the gun at Hector. Berberna then fled. Berberna then heard gunshots. He returned a short time later and saw the deceased lying in the street in front of Greg's house at 2828 N. Hutchinson St. Berberna described Greg as a B/M approx. 13yrs who resides at 2828 N. Hutchinson St.

Hutchinson St. when Hector Rodriquez and a B/M named Greg who lives at 2828 N. Hutchinson St. were arguing. He related that Hector refused to fight Greg, that Greg went into 2828 N. Hutchinson St. came out with a gun and began shooting Hector. He related that Greg fired six shots at Hector and that Hector fell down and that blood was coming from Hector's mouth. He related that he knows Greg for 6 months and that Greg lives at 2828 N. Hutchinson St. with his family.
