Mr. Chair,

The memo was not leaked to the press. We produced it in response to numerous public records requests we had received. As we have discussed the situation this week, and, as I mentioned to you last evening, we did not finalize it and send it yesterday because I was unable to reach you before close of business and I did not want to send it to you and then provide it as a public record without you knowing what was coming. During that conversation, I indicated we would finalize it and provide it to you this morning, then provide it to the Commission, and then to the press and others who requested it. Producing it was my call and mine alone. There was no ill intent and no weaponization of this situation by me or anyone else on staff.

We both recognize the challenges we have faced this week and the respect we have for each other and the work we have done thus far. If the timing of the release of this record has placed an additional burden on you or caused you to question the integrity of me or other members of the Commission staff, I regret that and offer my sincerely apology.
