Details: In 2004, FBI Los Angeles began reviewing PENTTBOM leads and related investigations. The purpose of the investigation was to identify 9/11 hijacker's Khaled Al-Mihdar (AL-MIHDHAR) and Nawaf Al-Hazmi's (AL-HAZMI) (American Airlines #77 that crashed into the Pentagon) whereabouts in Los Angeles for a two week period between 01/15/2000 and 02/04/2000, and to identify individuals in Los Angeles who assisted them.

During the investigation, FBI-LA identified video surveillance footage from Los Angeles International Airport (LAX) security cameras for 06/10/2000. The video surveillance footage shows San Diego Subject MOHDAR ABDULLAH and AL-HAZMI walking with AL-MIHDHAR at LAX before AL-MIHDHAR's return trip to Yemen to visit his family. More importantly, this footage also shows one additional unknown male subject (UNSUB) who appears to be accompanying ABDULLAH, AL-HAZMI and AL-MIHDHAR through LAX security. The UNSUB appears to be holding a camera and may have been conducting reconnaissance of LAX.

Per (F) on approximately advised that he had received an unsolicited telephone call from a reporter for the San Diego Union Tribune. During their telephone conversation, which centered on the upcoming sentencing of an individual convicted of a terrorism hoax, (P) advised that she had recently been in e-mail contact with ABDULLAH (currently believed to be in Yemen.) (P) advised that she had asked ABDULLAH about the recent NBC news article published on 09/11/06 regarding ABDULLAH's role in helping 9/11 hijackers Nawaf AL-HAZMI and Khalid AL-MIHDHAR. (Note -

advised that ABDULLAH did not answer any of her specific questions but related the following points:

On 10/03/06, AUSA (S) was again contacted by (P) (P) advised that she had received a second e-mail from ABDULLAH. (P) advised that ABUDALLAH related the following points:

- regarding this notorious story, the video corroborates what he has told the FBI from the beginning.
- the other individual in the video was either a friend of AL-HAZMI or AL-MIHDHAR and was residing in Los Angeles at the time (06/10/00).
- ABDULLAH was introduced to this individual on a previous occasion when this individual traveled down to San Diego to visit.
- this individual was residing in Los Angeles and the two hijackers knew the individual prior to coming down to San Diego.
- AL-MIHDHAR and AL-HAZMI were residing at Abdussatter Shaikh's home in San Diego in June, 2000. Telephone analysis was conducted from Shaikh's home number of (P) to Los Angeles area telephone numbers. During this analysis two additional witnesses that knew AL-HAZMI and AL-MIHDHAR were identified that resided in Los Angeles. The witnesses provided additional information on AL-HAZMI's AL-MIHDHAR activities that were previously unknown, but did not identify the UNSUB in the 06/10/2000 video nor have any knowledge about ABDULLAH's, AL-HAZMI's or AL-MIHDHAR's activities the day of 06/10/2000.

- Investigation revealed that Nawaf Al-Saud had two cellular telephones subscribed to him at the time: the (P) number that had contact with Abdussattar Shaikh's home telephone number and (P) which did not have any contact with Shaikh's home number.

address. In the records at the apartment complex, Los Angeles notes that a telephone number that was found in the records folder for Nawaf was

Investigation determined that Prince Nawaf Al-Saud was possibly attending Santa Monica College and UCLA extension while he was living in Los Angeles. Prince Nawaf Al-Saud that he may have had a small staff of people working for him as well. Otherwise, he did not have many "outside" friends and kept close to family members and other cousins.

It is believed that Prince Nawaf Al Saud is currently in Jeddah. Saudi Arabia and has a home telephone number of and a mobile number of the prince Nawaf Al Saud is engaged and lives in Jeddah. Los Angeles believes that Prince Nawaf Al Saud is considered a "poor prince" and is number 56 in line to the throne.

Los Angeles believes that Prince Nawaf Al Saud and his brother Meteb are not the individuals in the 06/10/2000 LAX video with 9/11 hijackers AL-MIHDHAR and AL-HAZMI. However, based on the telephone calls made between 06/04/2000-06/12/2000 from the user of one of Prince Nawaf Al Saud's telephones to where AL-HAZMI and AL-MIHDHAR were residing; and the three calls initiated on 06/05/2000 from where the AL-HAZMI and AL-MIHDHAR were residing to one of Prince Nawaf Al Saud's telephone; and the UNSUB seen in the 06/10/2000 LAX Video with the hijackers, Los Angeles' believes the following scenarios are possible:

- 1. An individual that was around, associated or worked for Prince Nawaf Al Saud is the UNSUB in the June, 2000 LAX video. This individual may have been the user of Prince Nawaf Al Saud's other telephone. Los Angeles believes that this is the most likely scenario.
- 2. An individual that was around, associated or worked for Prince Nawaf Al Saud brother Meteb Al Saud is the UNSUB in June, 2000 LAX Video. This individual may have used Prince Nawaf Al Saud's brother's Meteb's telephone.
- 3. Prince Nawaf Al Saud was the individual who was calling the hijackers at that time, but his association with them was not related to the LAX Video.
- 4. There is another possible explanation not determined as yet.



AL-MIHDHAR and AL-HAZMI were residing in San Diego in June, 2000. Telephone analysis was conducted from their home number in San Diego to Los Angeles area telephone numbers in June, 2000. There were eight calls between their home number and a telephone number subscribed to by Nawaf Al Saud, who was living at (P)

Los Angeles, California at that time. Investigation revealed that Nawaf Al-Saud had two cellular telephones subscribed to him at the time: a (P) number that had contact with where the hijackers were residing and (P) which did not have any contact with where the hijackers were residing.

FBI believes that Prince Nawaf Al Saud and his brother Meteb (who was possibly residing in Los Angeles at the time) are not the individuals in the 06/10/2000 LAX video with 9/11 hijackers AL-MIHDHAR and AL-HAZMI. However, based on the telephone calls made between 06/04/2000-06/12/2000 from the user of one of Prince Nawaf Al Saud's telephones to where AL-HAZMI and AL-MIHDHAR were residing; and the three calls initiated on 06/05/2000 from where the AL-HAZMI and AL-MIHDHAR were residing to one of Prince Nawaf Al Saud's telephones; and the UNSUB seen in the 06/10/2000 LAX Video with the hijackers, FBI believes the following scenarios are possible:

- 1. An individual that was around, associated or worked for Prince Nawaf Al Saud is the UNSUB in the June, 2000 LAX video. This individual may have borrowed Prince Nawaf Al Saud's other telephone. FBI believes that this is the most likely scenario.
- 2. An individual that was around, associated or worked for Prince Nawaf Al Saud's brother Meteb Al Saud is the UNSUB in June, 2000 LAX Video. This individual may have borrowed Prince Nawaf Al Saud's brother's Meteb's telephone.

FBI respectfully request to interview Prince Nawaf Al Saud and his brother Meteb Al Saud to:

- 1. Determine who may have used one their telephones numbers while they were living in Los Angeles, number (P), in June 2000
- 2. Determine if Prince Nawaf Al Saud or Meteb Al Saud can identify the UNSUB in the LAX Video.
